April 27, 2020 and April 28, 2020





Dear Janice and Andie:

As of today, the City of Hemphill has three contested races for the May 2, 2020 General Election. As required by law, I am providing you this Notice of Election to both notify you that the City is having an election and also to ask you to post both the English and Spanish version at the Sabine County Courthouse and to the Sabine County Website as required by HB933.

Janice, I will need you to forward me the Interlocal Agreement between the City and the County, allowing us to use your Early Voting Center and allowing us to lease the precinct counter and DRE machine from Sabine County/Sabine County Clerk. I will also need for you to order the ballots and program the precinct counter and DRE machine. I will provide you with a Sample Ballot or Ballot Proof as soon as I conduct the drawing for the places on the ballot on Friday, February 21, 2020. In addition, we will need someone from the Sabine County Clerk's office available to open and close the polling place during the Early Voting period and on election day.

Andie, I will be requesting a voter list before early voting begins and we will need someone from the Sabine County Voter Registrar's office available to verify voter registration status during the Early Voting period dates and times and on election day. Please note those dates and times on the Election Notice.
