

NOTICE OF NON-JUDICIAL FORECLOSURE SALE

WHEREAS, on September 15, 2023, Jesse James Gamez and Dolly Rivas as Grantor to Linda Booker, Trustee, executed a Deed of Trust to secure in the payment of that certain Promissory Note of even date therewith in the principal sum of **\$51,000.00 (Dollars)** payable to Homestead, LLC and further assigned to Casa Roble 1, said Deed of Trust being filed for record on September 29, 2023 as document # 232995 of the Jones County Clerks Records.
