

**JONES COUNTY COMMISSIONERS COURT
REGULAR MEETING
APRIL 12, 2021 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Todd McWilliams, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

1. **APPROVE MINUTES OF LAST REGULAR MEETING.** Commissioner Spraberry entered a motion to approve the minutes from the March 22, 2021 regular meeting as presented. Commissioner McWilliams seconded the motion with all other Commissioners voting aye.
2. **DISCUSS AND TAKE ACTION ON A BID SUBMITTED BY RAUL MARQUEZ FOR THE PURCHASE OF (R22631), LOTS 17, 18, 19, AND 20 IN BLOCK 24 OF THE R.D. MOORE ADDITION TO THE CITY OF HAMLIN, JONES COUNTY, TEXAS. THE BID AMOUNT IS \$200.00. COURT COST HAS BEEN WAIVED.** Commissioner Vivian entered a motion to approve a bid in the amount of \$200 submitted by Raul Marquez for the purchase of R22631. Commissioner Spalding seconded the motion with all other Commissioners voting aye. See Exhibit A.


The Extension Office submitted an office agenda for the Court to review. See Exhibit M.

Commissioner Vivian entered a motion to adjourn. Commissioner McWilliams seconded the motion with all other Commissioners voting aye.



County Judge
