

**JONES COUNTY COMMISSIONERS COURT
REGULAR MEETING
FEBRUARY 22, 2021 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Todd McWilliams, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk

1. **APPROVE MINUTES OF LAST REGULAR MEETING.** Commissioner Vivian entered a motion to approve the minutes from the February 8, 2021 regular meeting as presented. Commissioner Spalding seconded the motion with all other Commissioners voting aye.
2. **DISCUSS AND TAKE ACTION ON A BID SUBMITTED BY ANTHONY RAMOS FOR THE PURCHASE OF R18134, A 1.00 ACRE OF A 2.00 ACRE TRACT, OF THE N/2 TRACT OF SURVEY 10, BLOCK 1, T & NO RR COMPANY SURVEY, JONES COUNTY, TEXAS. THE BID AMOUNT IS \$1000.00. THE COURT COSTS ARE \$633.19.** Commissioner Spraberry entered a motion to approve a bid in the amount of \$1,000.00 submitted by Anthony Ramos for the purchase of R18134. Commissioner Vivian seconded the motion with all other Commissioners voting aye. See Exhibit A.

No action was taken by the Commissioners Court.




Commissioner Spraberry entered a motion to adjourn. Commissioner Vivian seconded the motion with all other Commissioners voting aye.



County Judge
