MARCH 8, 2021 - 9:00 AM**


The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk

- 1. APPROVE MINUTES OF LAST REGULAR MEETING.** Commissioner Spraberry entered a motion to approve the minutes from the February 22, 2021 regular meeting as presented. Commissioner Vivian seconded the motion with Commissioner Spalding and Judge Spurgin voting aye.
- 2. PRESENTATION OF INFORMATION REGARDING TEXAS SPEAKS SURVEY BEING CONDUCTED BY TEXAS A&M AGRILIFE EXTENSION OFFICE.**
No action was taken by the Commissioners Court.

No action was taken by the Commissioners Court.




Commissioner Vivian entered a motion to adjourn. Commissioner Spalding seconded the motion with Commissioner Spalding and Judge Spurgin voting aye.




County Judge




Commissioner Precinct 2




Commissioner Precinct 4
