## JONES COUNTY COMMISSIONERS COURT REGULAR MEETING SEPTEMBER 25, 2023 - 9:00 AM

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Ross Davis, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

#### 1. APPROVE MINUTES OF THE LAST REGULAR MEETING.

Commissioner Spalding entered a motion to approve the minutes for the September 11, 2023 meeting as presented. Commissioner Vivian seconded the motion with all other Commissioners voting aye.

#### 2. PUBLIC HEARING ON 2024 BUDGET.

Judge Spurgin opened the public hearing on the 2024 budget at 9:01 AM and closed the public hearing at 9:25 AM with one public comment being made by Gloria Little.

# 3. PUBLIC HEAERING ON 2023 TAX RATE.

Judge Spurgin opened the public hearing on the 2023 tax rate at 9:02 AM and closed the public hearing at 9:40 AM with no public comment.

## 19. DISCUSS AND TAKE ACTION ON 2023 TAX RATE.

Commissioner Vivian entered a motion that the 2023 property tax rate be decreased from the 2022 tax rate by the adoption of a tax rate of \$0.536555 which is effectively a 9.08% increased in the tax rate above the no new revenue tax rate. Maintenance and Operation (M&O) tax rate of \$0.494876 per \$100 valuation and Interest and Sinking (I&S) tax rate of \$0.041679 per \$100 valuation capped at \$0.80 per \$100 valuation. Maintenance of Public Roads tax rate of \$0.00 per \$100 valuation capped at \$0.15 per \$100 valuation. Farm to Market Road or Flood Control tax rate of \$0.00 per \$100 valuation capped at \$0.30 per \$100 valuation. Commissioner Davis seconded the motion. Judge Spurgin polled the Court. Commissioner Spalding voted aye. Commissioner Vivian voted aye. Commissioner Davis voted aye. Commissioner Spraberry voted aye. Judge Spurgin voted aye. See Exhibit F.

#### 20. DISCUSS AND TAKE ACTION ON RATIFYING VOTE ON 2023 TAX RATE.
