JONES COUNTY COMMISSIONERS COURT REGULAR MEETING MAY 8, 2023 - 9:00 AM

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Ross Davis, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

1. APPROVE MINUTES OF THE LAST REGULAR AND CALLED MEETINGS.

Commissioner Spalding entered a motion to approve the minutes from the April 24, 2023 regular meeting as well as the April 28, 2023 called meeting as presented. Commissioner Vivian seconded the motion with all other Commissioners voting aye.

2. THE JONES COUNTY COMMISSIONERS WILL CONDUCT A PUBLIC HEARING CONCERNING THE APPLICATION OF NEELY CLAY ENERGY AND VACA DEL SOL, LLC FOR THE ESTABLISHMENT OF THE "VACA DEL SOL REINVESTMENT ZONE" UNDER CHAPTER 312 OF THE TEXAS TAX CODE. THOSE REQUESTING TO SPEAK EITHER FOR OR AGAINST THE ESTABLISHMENT OF THE PROPOSED ZONE WILL BE REQUIRED TO SIGN IN ON A SHEET TO BE PROVIDED. THE COMMISSIONERS ARE LIMITING THE TIME ALLOTTED FOR PUBLIC COMMENT TO NO MORE THAN 5 MINUTES FOR EACH PERSON SPEAKING IN FAVOR OF ESTABLISHMENT OF THE PROPOSED ZONE AND NO MORE THAN 5 MINUTES FOR EACH PERSON SPEAKING IN OPPOSITION TO THE ESTABLISHMENT OF THE PROPOSED ZONE.

No public comment was made. Judge Spurgin closed the public hearing at 9:20 AM.

Commissioner Spraberry entered a motion to approve a resolution and order establishing a reinvestment zone in Jones County to be known as Vaca Del Sol Reinvestment Zone.
