

**JONES COUNTY COMMISSIONERS COURT

JUNE 26, 2023 - 9:00 AM**

**14. AMEND BUDGET AND APPROVE LINE ITEM TRANSFERS.**


Commissioner Spalding entered a motion to amend the budget and approve line item transfers.  
Commissioner Davis seconded the motion with all other Commissioners voting aye. See Exhibit D.


**15. PAY BILLS.**


Commissioner Spalding entered a motion to pay the bills as presented by the Auditor.  
Commissioner Vivian seconded the motion with all other Commissioners voting aye.




Commissioner Vivian entered a motion to adjourn. Commissioner Davis seconded the motion with all other Commissioners voting aye.


