

**JONES COUNTY COMMISSIONERS COURT
REGULAR MEETING
JANUARY 27, 2025 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Danny Collett, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk. Lonnie Vivian, Commissioner Precinct 2 joined by phone.

1. APPROVE MINUTES OF THE LAST REGULAR MEETING.

Commissioner Spalding entered a motion to approve the minutes from the January 13, 2025 regular meeting as presented. Commissioner Spraberry seconded the motion with Commissioner Collett and Judge Spurgin voting aye.

2. DISCUSS AND TAKE ACTION ON DISASTER DECLARATION FOR DR 4416 AND ALL ITEMS RELATED REGARDING FEMA AND TDEM FORMS AND REQUIREMENTS.

No action was taken by the Commissioners Court.

4. DISCUSS AND TAKE ACTION ON 259TH DISTRICT ATTORNEY INVESTIGATOR'S RACIAL PROFILE REPORT. Commissioner Spalding entered a motion to approve the 259th District Attorney Investigator's racial profile report as presented. Commissioner Spraberry seconded the motion with Commissioner Collette and Judge Spurgin voting aye. See Exhibit A.

5. DISCUSS AND TAKE ACTION ON KONEXUS CONTRACT FOR ALERT SYSTEM.

Commissioner Spraberry entered a motion to approve the one-year renewal contract with Konexus for alert system. Commissioner Spalding seconded the motion with Commissioner Collett and Judge Spurgin voting aye. See Exhibit B.

6. DISCUSS AND TAKE ACTION ON GENERATOR MAINTENANCE AGREEMENT.

Commissioner Spraberry entered a motion to approve the generator maintenance agreement with Clifford Power. Commissioner Spalding seconded the motion with Commissioner Collett and Judge Spurgin voting aye. See Exhibit C.

8. DISCUSS AND TAKE ACTION ON JONES COUNTY CONSTABLE'S OFFICE POLICIES.

Commissioner Spraberry entered a motion to approve the Constable's Office policy as presented. Commissioner Spalding seconded the motion with Commissioner Collett and Judge Spurgin voting aye. See Exhibit E.

9. DISCUSS AND TAKE ACTION ON COPIER MAINTENANCE AGREEMENT.

Commissioner Spalding entered a motion to replace the copy machine in the County Judge's office and approve the maintenance agreement with All Copy. Commissioner Spraberry seconded the motion with Commissioner Collett and Judge Spurgin voting aye. See Exhibit F.

10. DISCUSS AND TAKE ACTION TO ACCEPT DONATION TO SHERIFF'S DEPARTMENT AND APPROVE BUDGET AMENDMENT. Commissioner Spalding entered a motion to accept the donation of \$750 from Law Enforcement Partners to be used for crime prevention promotions. Commissioner Spraberry seconded the motion with Commissioner Collett and Judge Spurgin voting aye. See Exhibit G.

DISCUSS AND TAKE ACTION TO SELL USED SHERIFF VEHICLE TO CITY OF HAMLIN.** Commissioner Spraberry entered a motion to sell the 2015 Ford Explorer owned by the Sheriff's Department to the City of Hamlin for \$3000. This vehicle was going to be used as a trade in for the Tahoe's recently purchased for the Sheriff's Department. The \$3000 will be applied to the purchase of the Tahoe's. Commissioner Spalding seconded the motion with Commissioner Collett and Judge Spurgin voting aye. See Exhibit H.
- 12. DISCUSS AND TAKE ACTION ON ESTIMATE FOR UNINTERRUPTED POWER SUPPLY FOR JONES COUNTY JAIL.** Commissioner Spalding entered a motion to approve the purchase of an uninterrupted power supply for the Jail in the amount of \$14,353.00 from Lan Communications to be paid from permanent improvements. Commissioner Spraberry seconded the motion with Commissioner Collett and Judge Spurgin voting aye. See Exhibit I.
- 13. DISCUSS AND TAKE ACTION ON TREASURER'S REPORT.** Commissioner Spraberry entered a motion to approve the Treasurer's report. Commissioner Spalding seconded the motion with all other Commissioners voting aye. See Exhibit J.


Commissioner Spraberry entered a motion to adjourn. Commissioner Spalding seconded the motion with all other Commissioners voting aye.




County Judge



Commissioner Precinct 1




Commissioner Precinct 2
