REGULAR MEETING
JULY 27, 2026 - 9:00 AM**

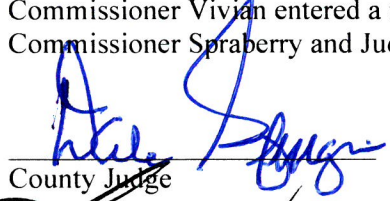

33. PAY BILLS.

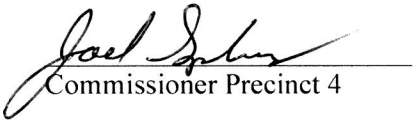

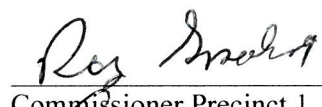

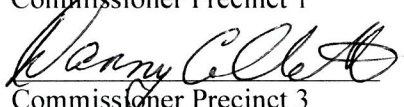
Commissioner Vivian entered a motion to adjourn. Commissioner Collett seconded the motion with Commissioner Spraberry and Judge Spurgin voting aye.


County Judge

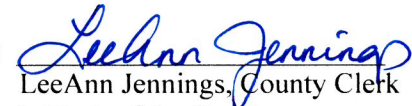

Commissioner Precinct 2
