

**JONES COUNTY COMMISSIONERS COURT
REGULAR MEETING
SEPTEMBER 22, 2025 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Roy Spalding, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Danny Collett, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, Jones County Clerk.

1. APPROVE MINUTES OF THE LAST REGULAR MEETING.

Commissioner Spalding entered a motion to pay the bills as presented by the Auditor. Commissioner Spraberry seconded the motion with all other Commissioners voting aye.

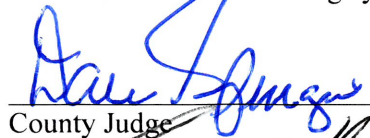

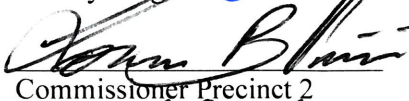

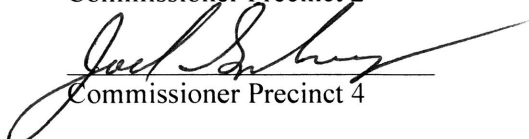
The Extension Office submitted an office agenda for the Court to review. See Exhibit H.

Commissioner Spraberry entered a motion to adjourn. Commissioner Collett seconded the motion with all other Commissioners voting aye.

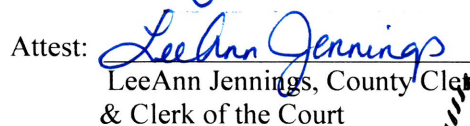

County Judge
