

**JONES COUNTY COMMISSIONERS COURT  
REGULAR MEETING  
DECEMBER 8, 2025 - 9:00 AM**

The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; Lonnie Vivian, Commissioner Precinct 2; Danny Collett, Commissioner Precinct 3; and Joel Spraberry, Commissioner Precinct 4. Roy Spalding, Commissioner Precinct 1; and LeeAnn Jennings, Jones County Clerk were absent.

**1. APPROVE MINUTES OF THE LAST REGULAR MEETING.**

Commissioner Vivian entered a motion to approve the minutes of the November 24, 2025 regular meeting as presented. Commissioner Collett seconded the motion with Commissioner Spraberry and Judge Spurgin voting aye.

**18. AMEND BUDGET AND APPROVE LINE-ITEM TRANSFERS.**



**19. PAY BILLS.**



**ADJOURN**


Commissioner Vivian entered a motion to adjourn. Commissioner Collett seconded the motion with Commissioner Spraberry and Judge Spurgin voting aye.


