JUNE 8, 2020 - 9:00 AM**


The Commissioner's Court of Jones County, Texas, met this day in regular session with the following members present: Dale Spurgin, County Judge, presiding; James Clawson, Commissioner Precinct 1; Lonnie Vivian, Commissioner Precinct 2; Ross Davis, Commissioner Precinct 3; Joel Spraberry, Commissioner Precinct 4; and LeeAnn Jennings, County Clerk.


- 1. APPROVE MINUTES OF LAST REGULAR MEETING.** Commissioner Spraberry entered a motion to approve the minutes from the May 26, 2020 regular meeting as presented. Commissioner Davis seconded the motion with all other Commissioners voting aye.
- 2. DISCUSS AND TAKE ACTION ON APPROVING ALL TRUST PROPERTY BIDS AS ONE ACTION ITEM. AGENDA ITEMS 3-6.** Commissioner Davis entered a motion to approve agenda items three through six as one action item. Commissioner Spraberry seconded the motion with all other Commissioners voting aye.




Commissioner Clawson entered a motion to adjourn. Commissioner Vivian seconded the motion with all other Commissioners voting aye.



County Judge
